Medicare Shared Savings Program (MSSP) SNF 3-Day Rule Waiver Program

Program

The SNF 3-Day Rule Waiver allows for eligible Medicare Shared Savings Program (MSSP) beneficiaries to be admitted to a skilled nursing facility (SNF) for extended-care skilled nursing or skilled rehabilitative services without the need for a 3-day inpatient hospital stay proceeding the admission.

Waiver Highlights


- Does not change or expand Medicare SNF benefits for beneficiaries
- Does not change freedom of choice rights for beneficiary
- Patients cannot be held financially liable for claims rejected by CMS for lack of a qualifying 3-day hospital stay
- 90-day grace period permits payment for SNF services provided without a
 qualifying 3-day inpatient hospital stay to certain beneficiaries who were initially
 included on the ACO's prospective assignment list but who were subsequently
 excluded from a quarterly exclusion report during the performance year if such
 services would otherwise be covered under the SNF 3-Day Rule Waiver.

Patient Eligibility Criteria

- Must be an assigned beneficiary of the ACO under the MSSP program
- Cannot be a resident of a SNF or other long-term care setting (assisted living is not considered a long-term care setting for the waiver)
- Must be medically stable
- Cannot require inpatient or further inpatient hospital evaluation or treatment
- Must have certain and confirmed diagnoses
- Have an identified skilled nursing or rehabilitation need that cannot be delivered in an outpatient setting
- Have been evaluated and approved for SNF admission within 3 days prior to the SNF admission by an ACO provider
